

Elderly Crime Has Many Faces

There seems to be no end to the various ways seniors can be defrauded and it seems that the "con artist" has become even more sophisticated. The scams targeting older people have become so common that they are now considered "the crime of the 21st century."

Help protect your loved ones, share the following tips:

- Shred documents that could be useful to criminals: bank statements, credit card statements and offers for credit cards, and other financial information.
- Add seniors to the national Do-Not-Call Registry (1-888-382-1222 or www.donotcall.gov). Instruct them to hang up their phone if they receive solicitation calls. Do not open the door or if need be, close the door on demanding, unwanted, unsolicited visitors.
- Insist that a senior never give out personal information. Do not agree to give money over the phone, rather, ask for written information to be sent through the mail. The best rule of thumb is to "never provide information in a phone call that you did not initiate.
- Watch for individuals who have befriended a loved one. Ask to talk to the new friend to find out more about them. A thief will not stick around long to chat!
- If you can't be there for a senior, find trustworthy people who can serve as eyes and ears for them by screening door-to-door scammers and others who try to exploit by telephone or computer.

New Procedure for Background Checks

People who now are applying for a PCA position are required to provide their fingerprints. The fingerprint process should take five-to-ten minutes and is completed by a trained technician.

When you go to the fingerprint service location, you **MUST** bring both your Fingerprint Authorization Form and your driver's license, government-issued ID, or other acceptable form of identification.

You have up to 14 days to be fingerprinted after you receive your Fingerprint Authorization Form.

This new procedure does not affect current SHC employees as long as you have worked any hours within 120 days. Most people only need one study unless there is a break in their affiliation with the entity. A new background study must be done when:

- A person quits and is later rehired
- A person is absent/inactive for 120 days or more
- A name change
- Waivered services such as respite or homemaking are added to your job duties

It is extremely important to work at least 1 shift in a 120 day period. If you have any questions, please contact Kris in HR.

Here are a couple of Fall recipes shared by Sandy (client)

Pumpkin Quesadillas

- 2 cups canned pure pumpkin puree
- 1 teaspoon ground cumin
- 8 flour tortillas (8 inch)
- 4 ounces goat cheese, crumbled
- 1/2 cup chopped walnuts, toasted
- 1/4 cup vegetable oil



In bowl, stir pumpkin and cumin; season. Spread over 4 tortillas. Sprinkle with cheese and nuts. Top with remaining tortillas. In large skillet, heat 1 tbsp. oil over medium-low. Cook quesadillas 1 at a time, turning once and adding more oil between batches, until browned, about 3 minutes. Cut into wedges.

Pumpkin Seeds

- 2 cups seeds- washed
 - 1-1/2 tsp. oil
 - 1-1/4 tsp. seasoned or regular salt (my favorite is garlic salt)
- Bake 250 for 3 hours/stirring occasionally
